

SECOND AMENDMENT TO THE DMC-ODS MEMORANDUM OF UNDERSTANDING

This second amendment effective September 1, 2026 amends the DMC-ODS Memorandum of Understanding, (as amended, the "MOU") between Santa Cruz-Monterey-Merced-San Benito-Mariposa Managed Medical Care Commission, a California public entity, operating as Central California Alliance for Health ("MCP") and County of Mariposa Behavioral Health ("DMC-ODS").

WHEREAS, The parties entered into the MOU effective January 1, 2024;

WHEREAS, The parties would like to amend the MOU to extend the term for an additional three years through December 31, 2029, as set forth below.

NOW, THEREFORE, the parties hereby amend the MOU as follows:

1. **Amendment.** The following modifications shall be incorporated into the Agreement:
 - a. Section 2, Term, shall be deleted in its entirety and replaced in full with the following:

"2. Term. This MOU is in effect as of the Effective Date and continues for a term of six (6) years, or as amended in accordance with Section 14.f of this MOU."
2. **Modification.** Except as specifically modified by this second amendment, all terms and conditions of the MOU shall remain in effect; provided however, if there is any conflict between the terms of this second amendment and the MOU, then the terms of this second amendment shall govern.
3. **Capitalized Terms.** All capitalized terms used, but not defined, in this second amendment shall have the meanings attributed to such terms in the MOU.
4. **Counterparts.** This second amendment may be executed in counterparts or via electronic signature, each of which shall be deemed to be an original and all of such counterparts or electronically signed documents shall together constitute one and the same second amendment.

The parties are signing this second amendment effective on the date stated in the introductory clause.
