# **POSITION SUMMARY**

Under direction, this position:

- 1. Creates, tests, implements and maintains enterprise software systems and databases to support the business needs of the Alliance
- 2. Conducts estimation and sprint planning for software projects as part of the Agile development cycle at the Alliance
- 3. Performs other duties as assigned

## DISTINGUISHING CHARACTERISTICS

The Software Developer III - Application Development is the advanced working level in the Software Developer - Application Development series and is distinguished from the lower-level Software Developer II - Application Development by the former's responsibility for working independently with customers to refine requirements, design robust solutions, and build innovative application implementations. This classification is distinguished from the Software Developer IV - Application Development by the latter's responsibility for working with the most critical applications and systems and leading software development projects.

#### **RESPONSIBILITIES**

- 1. Plans, schedules, and coordinates the design, development, testing, implementation and modification of software applications using appropriate design techniques with duties including but not limited to:
  - Creating applications to move, extract, transform and load data to and from disparate data systems, formats or files
  - Adding new features to existing applications using .NET technologies, based on regulatory needs or user requests.
  - Ensuring timely response to production issues, including assessing bug reports, analyzing error messages or logs, and making recommendations on potentials fixes
  - Developing user instructions, operational instructions, and design documentation according to IT group standards
  - Adapting purchased software systems to conform to user constraints and requirements
  - Creating reports from user requests, either by creating programs or through third party software
- 2. Conducts estimation and sprint planning for software projects as part of the Agile development cycle at the Alliance, with duties including but not limited to:
  - Performing estimation and sprint planning by interacting with project managers, product owners, and other Alliance staff to determine and validate the business needs and requirements

- Proposing, designing, and developing solutions based on requested feature sets and business requirements
- Planning, scheduling, and coordinating the development, testing and implementation of software applications
- Coordinating project development and maintenance with users, staff, vendors, and outside agencies
- 3. Performs other duties, as assigned by management
